

**VILLAGE OF TOBACCOVILLE
COUNCIL MEETING MINUTES
Thursday, July 7, 2016 - 7 p.m.**

CALL TO ORDER

Mayor Billy McHone called the meeting to order and gave the invocation. The following elected officials and staff were present: Mayor Billy McHone, Mayor Pro Tem Myron Marion, Council Members Joyce McGee and Lori Shore-Smith, Attorney Elliot Fus, Administrator Dan Corder, and Clerk Robin Key. APPROVAL OF MINUTES

Mayor Pro Tem Marion made a motion to approve the June 2, 2016 Council Meeting Minutes. Council Member McGee seconded the motion. The vote was unanimous. (Attachment)

ADMINISTRATOR'S UPDATE

TAX COLLECTION ORDINANCES

Mayor Pro Tem Marion made a motion to adopt Ordinance #158 *Empowering the Forsyth County Tax Collector to Collect Back Taxes* and Ordinance #159 *Empowering the Forsyth County Tax Collection to Collect 2016 Taxes* for the Village of Tobacoville. Council Member Shore-Smith seconded. The vote was unanimous. (Ordinances attached)

COUNCIL VACANCY DISCUSSION

Mayor McHone made a motion to appoint Steve Wood to fill the vacant seat on the Council. Council Member McGee seconded. The vote was taken as follows: Voting *yes*: Mayor Billy McHone and Council Member Joyce McGee; Voting *no*: Mayor Pro tem Myron Marion and

Council Member Lori Shore-Smith. The motion failed for lack of a majority. Notice of the vacant seat on the Council will be posted on the Village website.
